The assessment methods are versatile and rigorous. They are consistent with the material thought and contribute to high quality learning and performance. In several modules only one mode of assessment is available. Performance would be assessed more objectively as a weighted average of two different forms of assessment, for instance more quantitatively oriented exam and a term paper or timed essay. I do understand the time and resource constraints of achieving this in large size classes.

Performance is satisfactory and consistent with that of comparable institutions in the UK. The distribution of marks is satisfactory. On average, students perform well in both quantitatively and qualitatively oriented modules and assessments.
