The aims and the learning outcomes of the programme are in line with the structure of the MA economics; also the standards employed by members of staff contributing to the programmes are appropriate for the award of the degree.

Yes; the Aims and the ILOs of the programme are perfectly in line with those of equivalent programmes offered by Economics Departments in the UK.

The assessment methods are consistent with the learning outcomes and the procedures for the award of marks are rather robust.

Quality of teaching is good across the board. The Econometrics module seems to be in good shape and there is consistency between the marks of the coursework and the exam's marks.

Yes. The students have a variety of opportunities to show their achievements.

The cohort seems rather good in most exams although some students seem to find difficult some topics in Microeconomics.

Thank you very much for your report and for having served as an External Examiner on our programmes again this year. Your favourable comments about the learning outcomes, research-influenced curriculum, quality of teaching, assessment methods and marking procedures on our programmes, and about the administrative arrangements at Leeds University Business School, are much appreciated.

With regard to your comment on the difficulties that some students seem to have encountered with some of the exam questions for the Microeconomics module, the module leader has offered the following response: "The students performed a little better on some questions than others. This is likely to reflect over-reliance on the textual contents of practice essays based on last year's exam paper. The questions where they fell down were ones where the focus of the question had moved more substantially. I will warn the students about this next year, and take steps to avoid a repeat."

With regard to your remark on the resit exam papers having been sent to you for scrutiny too close to the examination date in August, I am pleased to report that it is now our standard practice to request module leaders to submit simultaneously the main exam paper for January/May examinations and the corresponding resit exam paper for August examinations. In future, therefore, you will receive resit exam papers to scrutinise well in advance of the examination date in August.

We trust these measures will adequately address the issues you have raised.
