The structure, content and delivery of the programme are entirely commensurate with the level of the award. The standards of teaching and assessment are appropriate to achieve the intended learning outcomes, although the 100% coursework modules would benefit from an element of individual assessment. The students benefit from a very high quality learning environment and outstanding academic staff.

Yes, the aims and ILOs are clear and have evolved in relation to previous years. They are commensurate with other programmes with which I am familiar.

The assessment methods are fine, although the marks for CIVE 5190M are high relative to the remainder of the programme. Looking at the assessment for this module it would seem that some at the upper end of the marks range are higher than might be expected. This was discussed at the board and the module leader is no longer employed by the University and so this is unlikely to be in issue in the future.

4. **Were students given adequate opportunity to demonstrate their achievement of the Aims and ILOs?**
- *The academic standards demonstrated by the students and, where possible, their performance in relation to students on comparable courses;*

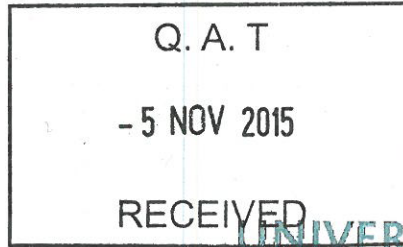
