The exam comprised a range of activities which tested key language skills. Assessments for marking and classification were clear.

The exam papers were designed to test key language skills at different levels, therefore students had opportunities to demonstrate their language competencies accordingly. There was a range of levels attained by different students, as would be expected. The papers suggested that there had been a good level of teaching, learning and assessment.
