## Guidance for UKRI funded PGRs on maternity, paternity, parental and adoption leave

ANNEX I – showing repayment requirements if the award holder withdraws from study.

If the award holder withdraws from study after the 26 or 39 weeks of paid maternity/adoption leave OR withdraws from study after 39 weeks paid and 13 weeks unpaid maternity/shared parental/adoption leave, then they will repay in full the total amount of funding received. A sliding scale applies if the award holder withdraws after this period:
